State of the Nation

35.3% of Americans say the country is headed in the right direction while 56.3 say it is on the wrong track. [Real Clear Politics, 1/28-3/1]

According to a Fox News poll, 36% of Americans are satisfied with the direction of the country while 63% are dissatisfied. This is the highest satisfaction level since November 2016 when 37% expressed their satisfaction. By November 2017, the satisfaction level had fallen to 21%. These findings indicate a significant jump in the public satisfaction level over the last four months.

67% of Republicans are satisfied with the direction of the country. This is the highest level of satisfaction since prior to January 2016. On the other hand, only 13% of Democrats are satisfied and 31% of Independents are satisfied.

63% of Americans are optimistic about the U.S. economy, 38% think the job situation in their area is getting better. In terms of their personal financial situation, 23% say they are getting ahead and 24% say they are falling behind. Folks are equally divided--29% Yes/28% No--on whether they have more money in their pockets as compared to a year ago. [Fox News, 2/13/18]

34% of Americans are satisfied with the size and power of the federal government while 38% are satisfied with how well the U.S. government works. [Gallup, 2/14/18 and 2/28/18]

Employment

The official BLS seasonally adjusted unemployment rate for February 2017 is 4.1%, this is identical to the October and November numbers and the lowest it has been since January 2001 when the rate was 3.9%.

The unemployment rate for African Americans in the 4th quarter of 2017 was 7.0% and the white unemployment rate was 3.4%. [BLS]

If one takes into account the total number of unemployed + those marginally attached to the labor force + those working part-time who want full-time work, the unemployment rate for February 2018 is 8.2%. [BLS data is based on those 16 years of age and older.]

In February 2018, initial claims for unemployment benefits hit the lowest level since December 1969. [WSJ, 3/2/18]

SEC regulations now require that companies report the pay of their chief executives and the pay of their median employee. A recent survey of 356 public companies found that the CEO-to-median pay ratio was 140 to 1. Companies above \$15 billion in annual sales had a ratio of 263 to 1. Companies with 43,000 or more employees had a ratio of 318 to 1. So far, the information for roughly 20 companies has been released. Honeywell reported a ratio of 333 to 1 and Teva Pharmaceuticals disclosed a ratio of 302 to 1. [WP, 2/24/18]

The Southern Poverty Law Center has identified 954 organizations which it describes as a “hate” groups. The number of organizations fitting that definition has grown from 917 groups in 2016 and 892 groups in 2016.

The number of groups defined as neo-Nazi groups has grown from 99 to 121, the number of anti-Muslim groups grew from 101 to 114 groups, and the number of anti-immigrant groups grew from 14 – 22. Two “men’s rights” groups have been added to the lists for the first time. [WP, 2/22/18]

78% of registered voters say that gun policy will be “extremely/very important” to their vote in November.

45% of registered voters say they would be less likely to vote for a candidate for Congress in their district if they heard that the candidate had accepted a

campaign donation from the National Rifle Association. 14% would be more likely to vote for that candidate. [CNN SSRS, 2/23/18]

The National Rifle Association is now basically aligned with the Republican Party.

In 1992 the NRA backed 115 Democrats for Congress. By 2010 that number dropped to 65. And by 2016 the number of Democrats supported by the NRA had dropped to 4.

The NRA is no longer just about guns. The group recently gave its “Courage under Fire Award” to the Federal Communication Commission for repealing net neutrality.

15-24 year olds

The Public Religion Research Institute (PRRI), along with MTV, conducted a survey of young people 15-24 years of age. Here are select findings from that survey.

- 25% of young people report having been targeted or treated unfairly in the last 12 months because of their race, ethnicity, gender, sexual orientation or gender identity, immigration status or religion.
- 84% of young people say Muslims face substantial discrimination in the United States
- 49% of young women who have been targeted fear for their personal safety. 32% of men have the same fears.
- Young women are more politically and socially engaged than young men. 48% of young women and 39% of young men say they have signed an online petition.
- 63% of young women believe that women face a lot of discrimination in the U.S. 56% of young men take the opposite view.
- 75% of young people believe that there is at least some pressure for men to act in traditionally masculine ways.
- 77% say America is very divided by politics, 57% say it is very divided by wealth or income, 48% say the country is very divided by race but only 38% say it is divided by religion.

- 56% of young people say discrimination against transgender people has increased in the last 12 months as has discrimination against black people.
- 74% of young people say that Muslims are portrayed in the news media and entertainment in a way that promotes negative stereotypes.
- 66% of young people say that the media/entertainment industries promote negative stereotypes of black people.
- 59% of young people who experience discrimination say it was direct and purposeful. 40% percent say the discrimination was indirect and possibly unintentional.
- 44% of young people say they have witnessed someone being targeted or treated unfairly because of their gender or have experienced it themselves in the last year. Only 12% of young people report having been personally targeted or mistreated due to their gender.
- 58% of young people report that they have personally intervened when they witnessed a friend or family member being targeted or treated unfairly. But only 33% reported intervening when they did not know the person being targeted.
- 68% of young Americans agree that women often have to be more qualified than men to be considered for the same job. 67% of the public as a whole have the same view. [PRRI, 7/19-8/3/27]

This and That

Here is a story of love and marriage in America.

When folks were asked to name the most important reasons for getting married...

- 88% said love
- 81% said making a lifelong commitment
- 76% said companionship
- 49% said having children
- Several other reasons were mentioned, each getting 30% or less.

71% say it is important for a man to be able to support a family financially in order to be a good husband or partner. 32% said the same thing for women to be a good wife or partner.

7% of adults were cohabiting in 2016. Half of cohabiters are younger than 35 years of age.

40% of new marriages involve a remarriage for at least one of the people.

Intermarriage in the United States has steadily increased from 3% in 1967 to 17% in 2015.

Support for same-sex marriage has gone from 37% in 2007 to 62% in 2017.

Of people married before 1960, 81% were married to a spouse of the same religion. In 2014 that number was 61%.

As of 2015, 15% of American adults have used an online dating site or mobile dating apps. That is an increase from 11% in 2013.

About President Trump

The President seems to think he knows everything and therefore does not listen to those who truly do know. He clearly has no idea of the consequences. [WW]

The president has announced tariffs of 25% on steel imports and 10% on aluminum. It is not clear whether any trading partners will be exempt. The open question is whether this decision will trigger a trade confrontation with China, the European Union and other world trade players. [Politico, 3/1/18]

On March 7th, Sarah Sanders said in her daily press briefing that there may be exceptions to the tariff for countries like Canada and Mexico.

U.S. companies that use aluminum, like soda companies, will be forced to raise prices for U.S. consumers as will automobile companies and construction companies that use steel.

The provision that the President is planning to use to impose these tariffs is Section 232 of the Trade Expansion Act of 1962. It requires a finding that there is a national security reason for imposition of the tariff. Given the appropriate finding, the President is authorized to impose tariffs without the involvement of Congress. (If you would like more information about Section 232 and these two metals go to commerce.gov.)

While the President talks about trying to pressure China for underwriting exports and the Chinese are not particularly large suppliers of steel or aluminum to the U.S. (10% of steel imports and 2% of aluminum) they are expected to respond if the President goes ahead with his plan for tariffs.

Folks who follow this issue believe the Chinese will respond in a proportional fashion, probably going after U.S. financial institutions and U.S. agriculture products. [WW]

There is always the chance that the President will change his mind before the rules are set forth, as he has done with gun control. He has until mid-April to make a final decision on both tariffs.

“I don’t believe any country in the world is going to retaliate for the simple reason we are the most lucrative and biggest market in the world.” -Peter Navarro, the White House trade advisor who along with the Secretary of Commerce pushed for the policy against the advice of other senior White House Staff like Economic advisor Gary Cohn. [WSJ, 3/3/18]

Cohn announced his resignation from the White House on March 6th. Reportedly, Cohn considered resigning after Charlottesville. Apparently the President’s decision to announce these tariffs without any advance discussion let alone following Cohn’s advice was the last straw.

These potential actions on tariffs have apparently been opposed by Secretaries Mattis and Tillerson.

Here is a list of foreign suppliers of steel to the United States in 2017: Canada 16% , Brazil 14%, S. Korea 10%, Mexico 9%, Russia 8%, Turkey 6%, Japan 5%, Taiwan 4%, Germany 3%, India 2%, China 2% ; other countries 21%.

Here are the foreign suppliers of aluminum to the United States in 2017: Canada 43%, UAE 10%, China 10%, Russia 11%, Other 26%.

Of particular note is the amount of each of these metals that come from Canada and Mexico. Here are some facts about trade between the United States and Canada and the United States and Mexico.

U.S. goods and services trade with Canada totaled an estimated \$627.8 billion in 2016. Exports were \$320.1 billion; imports were \$307.6 billion. The U.S. Goods and services trade surplus with Canada was \$12.5 billion.

U.S. good and services trade with Mexico totaled an estimated \$579.7 billion in 2016. Exports were \$262.0 billion; imports were \$317.6 billion. The U.S. goods and services trade deficit with Mexico was \$55.6 billion in 2016.

Canada is currently the 2nd largest goods trading partner of the United States. Mexico is currently the 3rd largest goods trading partner of the United States.

Canada was the United States' 1st largest goods export market in 2016 and Mexico was the second largest goods export market in that year.

President Trump claimed that his first State of the Union speech on January 30, 2018, which was watched by 45.6 million people watched, had the highest number of viewers in history.

That claim does not exactly comport with the facts.

Five other State of the Union addresses have exceeded Trump's in terms of audience size. The largest was President George W. Bush who drew 62.06 million viewers in 2003; followed by Bill Clinton with 53.08 million viewers in 1998;

followed by George W. Bush with 51.77 viewers in 2002; followed by Barack Obama with 48.1 viewers in 2010; followed by Bill Clinton in 1994 with 45.8 viewers.

Trump did have an audience of 47.74 million viewers for a joint session of Congress in January of 2017. Obama had 52.37 million viewers for the same speech in 2009.

Disassembling

In 2016 the government proposed a requirement that new, heavy trucks have potentially life-saving software that would electronically limit speeds. It has been delayed indefinitely by the Transportation Department as part of a retreat from various regulations.

The Associated Press reports that Trump's first year in office shows that a dozen safety rules under development or already adopted have been repealed, withdrawn, delayed or put on the back burner. [AP]

The U.S. Department of the Treasury intends to scrap nearly 300 tax rules in keeping with President Donald Trump's executive order to cut back on regulatory burdens. [Public Policy Law360, 2/13/18]

The 2019 Trump budget proposes to cut the funding of 11 departments and agencies and raises the budgets of 7 departments and agencies.

The EPA and Small Business Administration are the entities with highest percentage of cuts and Veterans Affairs is the agency whose budget has grown by

the greatest percentage. (These numbers do not include mandatory spending programs like Medicare and food stamps.)

President Donald Trump's March 5 deadline to wind down the DACA program arrived Monday, largely mooted by federal court injunctions. But the lives of thousands of DREAMers could still be upended, POLITICO's Ted Hesson reports.

"The problem arises chiefly from the Department of Homeland Security's refusal to prioritize those DACA renewals due to expire soonest," writes Hesson. "Instead, the applications are being processed in the order in which they were filed. Consequently, many so-called Dreamers who've applied to renew will see their DACA protections expire before DHS acts, increasing

their risk of being fired from their jobs or, possibly, being arrested and deported." [Politico, 3/6/18]

Despite being allocated \$120 million since 2015 to oppose foreign efforts to interfere in American elections, the State Department has spent \$0 of that. At the current time, zero of the 23 analysts in the Global Engagement Center assigned to counter Russian misinformation campaigns speak Russian.

Tillerson has voiced skepticism that the United States is even capable of countering the Russian threat. "If it's their intention to interfere, they're going to find ways to do that," Mr. Tillerson said in an interview last month with Fox News. "And we can take steps we can take, but this is something that once they decide they are going to do it, it's very difficult to pre-empt it." [NYT]

The Trump administration has drafted new rules making it harder for current foreigners in the United States who receive tax-funded public benefits, to obtain permanent residency. The proposed rules by DHS would be used "to determine if they could become a public burden." This would be a departure from current long standing policy of not using the benefits a foreigner uses to determine how eligible they would be for U.S. citizenship. [The Daily Beast, 2/8/18]

The Department of Homeland Security under the leadership of Secretary Kirstjen Nielsen, has said it is considering separating parents from their children as a means of deterring other families, most of them Central American, from undertaking the perilous trip necessary to reach the United States and seek asylum.

In a particular case cited in a Washington Post editorial on 3/5/18, a 7 year old girl was separated from her mother. There is no evidence that the child or her mother is a terrorist or otherwise dangerous. The mother is being held at a detention center in San Diego and the little girl at a detention center in Chicago. Mother and child could have been detained together in a family detention center.

The administration is moving to give restaurants and other employers more control over workers tips. Under the new proposal, employers could use workers tips for essentially any purpose, as long as the workers were directly paid at least the federal minimum wage of \$7.25 an hour. The Labor Department estimated that the rule would affect about one million waiters and waitresses and over 200,000 bartenders. Workers in other industries like hairstylists and manicurists would also be affected. [NYT, 2/4/18]

Restaurants

Debbie and I have eaten dinner three times at Passion Fish. The first visit was with Florence and Peter, the second with Gail and the third with Peter and Florence and Bonnie and Lou.

The second visit did not diminish our positive feelings after the first visit and the third visit continued the positive pattern.

As you enter the restaurant the greeter stand is to the left and ahead there is an L-shaped padded banquette and bench where guests can wait if their table is not ready. Just past that bench there is a tall table with 8 high seats.

The bar, a very large square with high chairs, is ahead slightly to the left. There are also several tables in the front. You then go down an aisle that takes you past a floor to ceiling glassed-in wine cabinet on the left and the open kitchen on the right.

Weather permitting there is a substantial outside dining area with umbrellas.

On our first visit Debbie and Florence had egg rolls and then the Chinese style Smoked lobster with Stir Fried Vegetables, Crispy spinach, Ginger-Garlic Soy Glaze.

Peter started with egg rolls with seafood and Jumbo Lump Crab Cakes. I opened with the Crab & Corn smoked Chowder followed by the Whole Crispy Flounder with Spicy Tamarind Chilli Nam Pla, Cucumber Sunomono Salad.

On our second visit Debbie and Gail had the Crab & Corn Chowder as well as the Soft Shell Crab Rolls and the Firecracker, which includes Tempura Shrimp, Spicy Crab, Seaweed Salad and Dynamite Tobiko Crunch.

I had the Char-Grilled Baby Octopus, Harissa Hummus, Smoked Tomato Chutney, Roasted Chickpeas and Blackend Mahi Mahi.

On our third visit Peter started with the shrimp egg roll followed for the second time by the Jumbo Lump crab cakes. Florence opened with fried oysters followed by the crab cakes.

Bonnie had oysters and the Sushi Tuna Roll. Lou had crab and corn chowder and the Jumbo Lump crab cakes.

Debbie had corn chowder and the Firecracker again. I had grilled oysters and Grilled Arctic Char and sweet potato fries.

The service was excellent on all three visits.

The restroom is fairly new and well maintained. There are two commode rooms. One is larger than the other to accommodate those with special needs. There is a single wall handling urinal with partial walls on each side but open at the front.

As you enter there is a large white counter that houses two sunken washbasins with a tall split mirror above the washbasin counter. The floor is made up of very long tile-like pieces.

Above and to the sides of the washbasin counter, the walls have a series of strips of striated wood like tiles. Inside the commode rooms there are very large tile-like walls to waist height. Above waist height the walls are painted in a yellowish color.

Debbie and I went to Succotash with Bev and Brady.

Succotash is located in the Old Equitable Co-operative Building Association building. The building was completed in 1912.

When you enter the restaurant you cannot help but be overwhelmed by the sheer size and particularly the height of the restaurant. There is a large, heavy wood square greeters stand straight ahead as you come through the front door.

The restaurant has two levels. On the main floor to the right there is a very long bar with many high chairs. To the left there is a banquette running the length of the room with tables on both sides and then farther to the left there are additional tables.

The second level is really a balcony that runs in a U shape around the entire room with the open end at the front door. At the far end of the second floor there is a separate room for dining and drinking. This room has old wood décor whereas the main restaurant is much more formal and very white.

The ceiling running the length of the building is a tent like glass structure.

Tom Sietsema in the Washington Post when reviewing the restaurant described it as, “9,500 square feet of gleaming dining rooms, multiple bars, free floating mezzanine and seemingly endless ceiling.”

The restaurant seems to be a bit noisy. Brady wisely requested a table on the second level at one end. It was quieter than the rest of the restaurant and provided the opportunity to see most of the restaurant from above. The upper level had booths and banquettes and four tops all the way around.

The menu is basically Southern fare with Asian accents.

Bev started with Fresh Burata, Crispy Pig Ears, shaved Brussel sprouts, Toasted Baguette with Miso Honey. For her entrée she chose Duck Schnitzel Country Ham, Mushroom Duxelle, Persimmon, Asian Pear, Celery Root Puree, Gravy.

Debbie opened with Maryland Goat Cheese Salad, Mirliton Pepper Relish, Poached Pears, Crispy Collards and Bourbon Vinaigrette. For her main course

she chose Dirty Fried Chicken Legs & Thighs, Honey Gochujang Sauce, Blue Cheese, Pickles, Nori Flakes.

Brady began with Blackened Octopus Smashed Red Potato, Broccoli Salad, Plum BBQ Sauce, Sour Cream and Chives followed by Spice Rub BBQ Pork Ribs Apple Cider Vinegar BBQ Sauce, Pickled Peppers, Fried Black Eyed Peas.

I went with one of my favorites Fried Green Tomato Salad, arugula, radishes, Buttermilk Dressing Feta Cheese. I then selected Crispy Blue Catfish Mint-Jalepena Aioli, Red Grapes, Lettuce Slaw, Burnt Lemon.

As you might expect there was considerable tasting of each other's selections.

The service was quite good.

Open 7 days a week. The restaurant does not have valet parking but there are a number of parking garages in close proximity and The Smith restaurant which is basically next door on the 9th street side, does have valet parking.
